
## **FISH HOUSES**

## **CHANNEL CAT TRICKS**

If you've ever had trouble hooking up with biting channel catfish, chances are, you're not to blame. Many anglers don't realize
that these fish have what dentists call an overbite, which makes it
difficult for them to bottom feed. To catch more channel cats, try
keeping your bait just of the bottom, which will increase your
chances of getting a good hook set. If your fishing an area with a
strong current, try using a three-way swivel. Tie your line to one
ring, your sinker to another, and a baited hook to the third. Doing so
allows the current to carry your bait several inches above the bottom
and into the strike zone, where cats are easier to hook. When fishing
slack water, such as in lakes or ponds, try keeping your bait afloat
with a small bobber rigged below your sinker, several inches from
the hook. Another tactic to try with a slip-sinker rig involves injecting your bait with air. Walleye anglers have successfully used this
method for years, and it works equally well on catfish.

## **CLEAR LAKE UPDATE**

Summer is here, and so are the weeds. They have taken over the lake, making fishing quite a challenge. There have been some walleye caught in the evening hours, if you can stand the mosquitos. Slip bobbers fished in the openings of weed beds, seems to be the way to go. Sunfish also continue to bite, and some nice ones are being caught. The water level continues to stay up due to the heavy rains we had this summer. Our weed removal project in front of the County Park has been going rather slow. Hopefully by the time you read this we will have almost finished. Due to the high water level, quite a few areas of cattails did not come back this year. This spring the DNR installed an outdoor toilet at the boat landing, which is a welcome addition to possibly the prettiest little lake in southern

Algae blooms are quite natural in the grand scheme of things, however, we here in r-southern Minnesota have an abundance of these blooms with an intensity that often chokes lakes and creates a water no one wants to use for any purpose. With that being as it is, it's time for examination of our input on an individual basis that may promote this type of over growth of algae, along with other undesirable aquatic plant life that proliferates many of our southern Minnesota lakes. We as individuals and land owners have the power to create an environment that will improve these events. ouch things as over use of fertilizers near lakes and streams, septic systems that are broken or out dated and no longer doing the job they were supposed to do, as well as poorly positioned animal feed lots and the maintaining of buffer strips of grass and plants near these areas of run-off are essen tial to clean usable water. Once we as individuals have our own systems in order, it is our duty to spread the word by talking to a neighbor or friend and explaining these things as well as the clear benefit they have to us all. If we cannot get a handle on these things that affect our water, the cost of reclaiming lakes, streams, and rivers, will become more and more expensive, making it less and less possible for us to not only reclaim these degraded systems, but also cost prohibitive to maintain lakes that have had a reclamation project done to them. One thing I think we are all for is a clean usable resource, be it lake, stream or river, how we get there may create controversy at times, but the end result of hard work towards a healthy system should not be jeopardized by turning our backs on what must be done to insure, that what created the degraded lake, stream or river, is not repeated for our future generations to pick up the bill, due to our unwillingness to make changes that are essential to ensure that it never happens again. This would surely be short-sighted and an insult to those who would have to inherit the degraded resource all over again and pay the fiddler once more. We as individuals and land owners have the ability to make our water much better, it's up to us to educate ourselves and promote land uses that create a situation that will allow nature to do it's job of natural filtration and purification.
