On Saturday, May 1st, a group from the 3M RRATS and the New Ulm Area Sport Fishermen took a bus ride to Belle Plaine to help clean up one of the worst dump sites that any of us had ever seen. We were told that about 250,000 tires had already been removed from the site, yet in the four hours we were there we pulled thousands of tires out of the flood plain. We also filled four large dump-

sters with garbage and piled up 7 or 8 tons of steel. There was also quite a bit of hazardous material in the form of propane and acetylene tanks, freon cylinders, batteries, and container of

waste oil and anti-freeze. It was amazing to see the amount we got cleaned up in such a short time. The guy from the MPCA was very impressed with the amount of work we got done.



Dear Commissioners,

We have been made aware of a proposed drainage project that will apparently impact the last naturally producing brown trout stream here in South Central Minnesota. It is proposed for ditch #58, which has a straight flow to Seven Mile Creek. Needless to say when we were made aware of this project by the DNR, and that it would have grave consequences for the stream, we became intensely interested. That particular stream is a favorite fishing hole for several of our members. One such member Dave Schoenberg of New Ulm, an attorney has enjoyed fishing there for years and was surprised and dismayed at the proposed project as it has been engineered. It appears there are many environmental consequences that simply could be offset by a better planned project. According to Hugh Vallient of the MNDNR fisheries at Waterville there are definite opportunities for improvement of drainage for producers as well as measures that could be taken to secure the habitat for brown trout. We have individually signed a petition for an EAW. We hope you take it seriously. There are 130 members in the club, many are from Nicollet County.

First Minnesota River Public Input Committee Meeting held April 21st in New Ulm

The first meeting of the Minnesota River Public Input Committee (PIC) was held on April 21st in New Ulm at the office of the Coalition for a Clean Minnesota RIver. 26 people attended from throughout the river basis. Larry, for the record, I was called by 4 people prior to the meeting to ask me if it was worth their time to attend. I answered "only if they made it so". Then I thought to myself, it would be a disservice to the public that lives and works here to not share information with the public about what is happening with regards to the river.

In the light of this I will re-invite all peoples of the basin, especially those whose jobs it is to work in this area, to these meetings It is crucial that we start letting the public know what's up.

At this meeting ground rules and purpose of the committee were explained and agreed upon. The PIC has autonomy and is designed, on our collective behalf, to give recommendations to all state agencies and the MInnesota River Basin Joint Powers Board as it pertains to the river.

Two Big Stone County Commissioners were on hand to report on two particular drainage projects in their county. It was decided that this group had no legal authority but would further research these. It was a thought that the Minnesota River Joint Powers Board may want to look at these particular projects and that the PIC was more about trying to come up with a better system and appropriate sequential approach to drainage in general and that we had no authority to solve their particular immediate needs. It was also noted that engineers who design drainage projects need to consider river effects in their plans before they move forward with the process. Future PIC meetings will have this on the agenda. On a related note, Mark Dittrich of the Minnesota Department of Agriculture reported at the meeting that group has been in discussions since last Summer called the Agricultural and Rural Water Management group and that it was probable that the legislature would be taking a good look at this within the next couple of years. They would be a good contact for us and could provide information.

Signage was discussed that would identify drainage ditches that have actual stream names on county and state roads. Bob Finley of Redwood-Cottonwood Rivers Control Area said he had some experience in this area and said it was a way to have people identify not only the watershed they live in but the one they are travelling through. A strategy to do this on a greater scale will be researched and discussed at up-coming meetings of the PIC and people were encouraged to come up with in class 7 "limited resource" streams. A discussion at the meeting surrounded the message that this sent to the people of the basin and that further clarification of this consideration needed to be made to the peoples of the watershed on a greater scale of what this is about.

A report was given on a huge volunteer effort to clean up a dump site near Belle Plaine. Tony Miller of the 3M River Restoration Action Team in New Ulm said they were coordinating a clean up day on Saturday May 1st. Details for anyone wishing to volunteer can call the CCMR office: 507-359-2346.

Bob Finley also reported that on June 28th through the 30th that there would be morning coffee meetings on the Cottonwood River. The last day they would be having a float down the river from highway 4 bridge to Flandrau State Park with activities to follow. The next meeting date is Wednesday, May 26th in New Ulm at the CCMR office at 7 p.m. To obtain directions, simply e-mail you request to yasure@mailcity.com


