



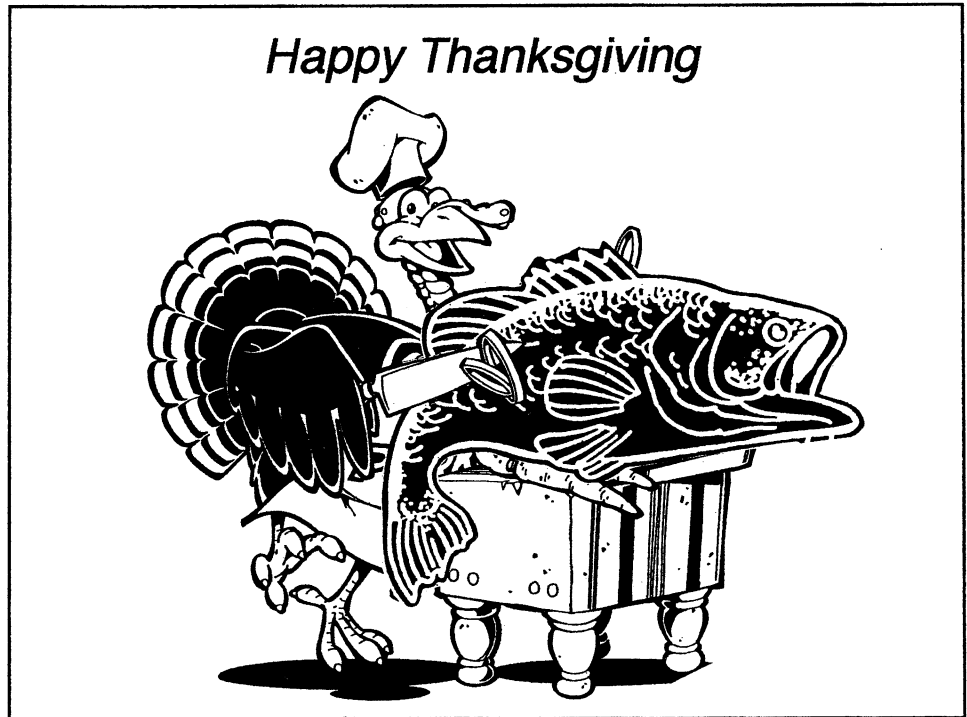

Annual Ice Fishing Trip Set

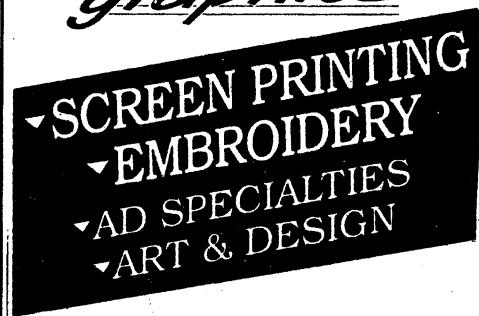
