Why We Fish

According to information by the American Sportfishing Association, the "Future of Fishing" surveys conducted in 1980, 1995 and 1999 found that fishing for relaxation went from the number four reason to fish in 1980 to the number one reason in 1999, nearly a 20 percent increase. Fishing to be with family and friends saw a 14 percent

increase, making it the number two reason to fish among angling respondents in 1999. Fishing for food saw approximately a 23 percent drop from 1980 to 1999, and fishing for sport dropped 13 percent. In 1999, about 13 percent said they fish for closeness to nature, whereas only 3 percent said they fished for trophy fish.

Clear Lake Update

It has been a long, hard winter on Clear Lake. The snow came very early, along with cloudy ice and very little sunshine which has put a lot of stress on the lake. We also had a power outage and the aeration system was off line for several days. We will be very lucky if the fish make it through the winter. Once the ice goes off we have sone work to do. The thin ice signs need to picked up

as soon as possible to prevent them from being damaged. We also need to dismantle and salvage the old fishing pier. Plans are being considered for the construction of a new pier. Hopefully it can be built and installed by the time the lake opens for fishing on July 1st. When the ice does go, we will need to act fast. Expect to be called at the last minute.

I just talked to Heather Baird, DNR fisheries, Waterville, recently and she had been out testing for the agency and levels were in the 2 to 3 parts range near the top and bottom respectively. That means we are climbing and we should be looking good for this spring spawning season. Remember that the lake is closed for fishing until July 1st of this year. I also talked with Hugh Vallient about maintenance of the fish barrier because of the snow pack this year. He said he would talk to the land owner and see that it was in place to avoid invasion of certain adult species.
