# Fishing contest a success

# Ditch-buffer bill may get passed this session

State Representative Rick Hansen (DFL from South St. Paul) and state Senator Dan Sparks (DFL from Austin) are working to get a ditch-buffer bill passed this session. Should the bill pass, it would go a long way toward cleaning up our state's waters and provide needed wildlife habitat.

Representative Hansen, an expert in soil and water management has put together long overdue changes in a plan that will bring long-term benefits. Being in leadership positions in the Dakota County Soil and Water Conservation District, Hansen has known about the issue for some time. In 2004 the SWCD passed a resolu-

tion which said the width of the buffer strips included should be clarified. The law required a 1-rod buffer-strip to be placed on each side of a newly dug ditch and also where existing ditches are improved. A rod is 16.5 feet long.

There was confusion over where the rod should start and end in the 1977 law. It was found in a survey taken in 1986-1987 that there wasn't much compliance to the law and today it still isn't.

In February, a ditch-buffer bill of Hansen's passed a House committee that is supported by farmers and environmentalists. It took a lot of work by many people to do a required study. The group, in 2005, got an appropriation in the Board of Water and Soil Resources budget for \$109,000, to look at the implementation of buffers strips and to do a literature review of their effectiveness. The study found ditch buffers protect water quality, reduce erosion and provide wildlife habitat. It is important to wildlife as it provides a corridor in which wildlife can move. The buffers reduce wind erosion and runoff which in turn protects water.

Although the bill did not pass last session, this session interest in ditch buffers has grown. A task force from the Board of Water and Soil Resources followed up on the recommendations and heard compelling testimony about the need to update drainage records, not only for the buffer requirement but for assessment and property taxes. Therefore the gov-

ernor budgeted \$500,000 for record modernization grants for local government. The bill which passed the House Environment and Natural Resources Committee, House File 577, Senate companion was authored by Senator Dan Sparks.

The landowners who benefit when there is a ditch cleanout or a new ditch established will pay for the buffers. Because the buffers will reduce the need for cleanout as well as other benefits, everyone in the watershed will benefit.

Although some legislators oppose the bills, there is really widespread support. Agricultural, environmental and many other groups are in support.
