BIG STONE II SINKS LIKE A STONE

News from Scott Sparlin Central Minnesota Municipal Power Agency announced today that the Big Stone II coal-fired power plant expansion project is dead. This decision will now save over 6,000,000,000 (yes, six billion!) gallons of non-recyclable water the plant would have taken annually from the river and its headwaters aquifer. Great gratitude is due to American Rivers, Clean Up the River Environment. The Coalition for a Clean Minnesota River, Friends of the Minnesota Valley, The Minnesota River Board, and the entire partnership who opposed using huge quantities of water from the Minnesota River for this ill-advised project. The need still exists to organize and convene a "border waters commission" to deal with these multi-state water-use issues—once and for all.

So, c'mon Governor! People in Minnesota showed that we care deeply about our surface and ground water in the last election. Now is the time to show your leadership qualities here at home and finish the job you



were elected to do as governor of this great state. Now is the time for you to offer to start the process: pick up the phone and call the other state leaders. The unpleasant controversy-part is over now; there are no reasonable excuses *not* to do it. It is truly a good day for the river. Let's hope that locally-generated renewable energy resources get more of the spotlight now. It's time.

*Criminality strikes NUASF! Someone has taken 6 LP tanks from one of our sheds! Motion was made and seconded to have all the locks changed on the sheds.


