We all were certainly pleasantly surprised and thrilled by The United States Department of the Interior's Secretary, Sally Jewell's recent visit to Minnesota on the 5th of November. It gave us a rare opportunity to reinforce our application to the National Blueway Initiative in person. I had the good fortune to meet with her about our application and the current status of the program. I urged her to help us keep the momentum and extensive Blueway network we have built over the last year and nine months going strong. She has directed us (The Blueway Working Team) to send a reaffirmation letter to her office which has been done already. Along with that I mentioned we were in the process of having a postcard blitz coming her way both in hard copy and electronically. The Secretary told me that was an excellent idea and it would be significant in her decision making as to moving forward. She expressed what challenges had arisen from some of the property rights organizations about the initiative, but that those had also been answered satisfactorily, as this initiative has nothing to do with property rights whatsoever. I did have a chance to emphasize to her the downside to not moving forward with the initiative. However, I

went away feeling she had a good grasp on that situation and what the down side of doing nothing would be. Lastly, I expressed a need for some quick answers within the near future. Given that decision, it will enable us to plan our Blueway initiative and what it will look like given the Departments participation or not. I did go away with a positive feeling, but like with all politics, you just never know. 
